To ensure safety and comfort for all, we require individuals to act appropriately at all times when they use our facilities or participate in our tennis program. You also understand that if you willfully damage any property or disobey these rules you will be subject to immediate discipline ranging from reprimand to ejection by the Club Manager, staff, or one of the Board.
